Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled

SEC. 3. That section 4785 of the Revised Statutes is hereby re-enacted and amended so as to read as follows:

"Sec. 4785. No agent or attorney of other person shall demand or receive any other compensation for his services in prosecuting a claim for pension or bounty land than such as the Commissioner of Pensions shall direct to be paid to him, not exceeding \$25; nor shall such agent, attorney or other person demand or receive such compensation, in whole or in part, until such pension or bounty-land claim shall be allowed: Provided, That in all claims allowed since June 20, 1878, where it shall appear to the satisfaction of the Commissioner of Pensions that the fee of \$10, or any part thereof, has not been paid, he shall cause the same to be deducted from the

pension and the pension agent to pay the same to the recognized attorney.

SEC. 4. That section 4786 of the Revised Statutes is hereby amended so as to read as follows: "Sec. 4786. The agent or attorney of record in the prosecution of the ease may cause to be filed with the Commissioner of Pensions duplicate articles af agreement without adaitional cost to the claimant, setting forth the fee agreed upon by the parties, which agreement shall be executed in the presence of and certified by some officer competent to administer oaths. In all cases where application is made for pension or bounty land, and no agreement is filed with the Commissioner as herein provided, the fee shall be \$10 and no more. And such articles of agreement as may hereafter be filed with the Commissioner of Pensions are not authorized, nor will they be recognized except in claims for original pensions, claims for increase of pension on account of new disability, in claims for restoration where a pensioner's name has been or may hereafter be dropped from the pension rolls on testimony taken by a special examiner, showing that the disability or cause of death, on account of which the pension was allowed, did not originate in the line of duty, and in cases of dependent relatives whose names have been or may hereafter be dropped from the rolls on like testimony, upon the ground of non-dependence, and in such other cases of difficulty and trouble as the Commissioner of Pensions may see fit to recognize them: Provincet, That no greater fee than \$10 shall be demanded, received, or allowed in any claim for pension or bounty land granted by special act of Congress, nor in any claim for increase of pension on account of the increase of the disability for which the pension had been allowed: And provided further, That no fee shall be demanded, received, or allowed in any claim for arrears of pension or arthe original claims in which such arrears of pension or of increase of pension may be allowed.

And if in the adjudication of any claim for pension in which such articles of agreement have been or may hereafter be filed it shall appear that the claimant had, prior to the execution thereof, paid to the attorney any sum for his services in such claim, and the amount so paid is not stipulated therein, then every such claim shall be adjudicated in the same manner as though no articles of agreement had been filed, deducting from the fee of \$10 allowed by law such sum as

claimant shall show that he has paid to his said attorney.

Any agent or attorney or other person instrumental in prosecuting any claim for pension or bounty land who shall directly or indirectly contract for, demand or receive or retain any greater compensation for his services or instrumentality in prosecuting a claim for pension or bounty land than is herein provided or for payment thereof at any other time or in any other manner than is herein provided, or who shall wrongfully withhold from a pensioner or claimant the whole or any part of the pension or claim allowed and due such pensioner or claimant, or the land-warrant issued to any such claimant shall be deemed guilty of a misdemeanor, and upon conviction thereof shall for every such offense be fined not exceeding \$500, or imprisoned at hard labor not exceeding two years, or both, in the discretion of the court.

NOTICE TO CLAIMANT.

This contract is permissible under the law but not compulsory.

READ THE FOLLOWING COPY OF THE STATUTE.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled

Sec. 3. That section 4785 of the Revised Statutes is hereby re-enacted and amended so as to read as follows:

"Sec. 4785. No agent or attorney or other person shall demand or receive any other compensation for his services in prosecuting a claim for pension or bounty land than such as the Commissioner of Pensions shall direct to be paid to him, not exceeding \$25% nor shall such agent, attorney or other person demand or receive such compensation, in whole or in part, until such pension or bounty-land claim shall be allowed: Provided, That in all claims allowed since June 20, 1878, where it shall appear to the satisfaction of the Commissioner of Pensions that the fee of \$10, or any part thereof, has not been paid, he shall cause the same to be deducted from the pension and the pension agent to pay the same to the recognized attorney."

SEC. 4. That section 4786 of the Revised Statutes is hereby amended so as to read as follows: "Sec. 4786. The agent or attorney of record in the prosecution of the case may cause to be filed with the Commissioner of Pensions duplicate articles af agreement without advitional cost to the claimant, setting forth the fee agreed upon by the parties, which agreement shall be executed in the presence of and certified by some officer competent to administer oaths. In all cases where application is made for pension or bounty land, and no agreement is filed with the Commissioner as herein provided, the fee shall be \$10 and no more. And such articles of agreement as may hereafter be filed with the Commissioner of Pensions are not authorized, nor will they be recognized except in claims for original pensions, claims for increase of pension on account of new disability, in claims for restoration where a pensioner's name has been or may hereafter be dropped from the pension-rolls on testimony taken by a special examiner, showing that the disability or cause of death, on account of which the pension was allowed, did not originate in the line of duty, and in cases of dependent relatives whose names have been or may hereafter be dropped from the rolls on like testimony, upon the ground of non-dependence, and in such other cases of difficulty and trouble as the Commissioner of Pensions may see fit to recognize them: Freviced, That no greater fee than \$10 shall be demanded, received, or allowed in any claim for pension or bounty land granted by special act of Congress, nor in any claim for increase of pension on account of the increase of the disability for which the pension had been allowed. And provided further, That no fee shall be demanded, received, or allowed in any claim for arrears of pension or arrears of increase of pension allowed by any act of Congress passed subsequent to the date of the allowance of the original claims in which such arrears of pension or of increase of pension may be allowed."


And if in the adjudication of any claim for pension in which such articles of agreement have been or may hereafter be filed it shall appear that the claimant had, prior to the execution thereof, paid to the attorney any sum for his services in such claim, and the amount so paid is not stipulated therein, then every such claim shall be adjudicated in the same manner as though no articles of agreement had been filed, deducting from the fee of \$10 allowed by law such sum as

claimant shall show that he has paid to his said attorney.

Any agent or attorney or other person instrumental in prosecuting any claim for pension or bounty land who shall directly or indirectly contract for, demand or receive or retain any greater compensation for his services or instrumentality in prosecuting a claim for pension or bounty land than is herein provided, or for payment thereof at any other time or in any other manner than is herein provided, or who shall wrongfully withhold from a pensioner or claimant the whole or any part of the pension or claim allowed and due such pensioner or claimant, or the land-warrant issued to any such claimant shall be deemed guilty of a misdemeanor, and upon conviction thereof shall for every such offense be fined not exceeding \$500, or imprisoned at hard labor not exceeding two years, or both, in the discretion of the court.

In the claim of Cyntha, widow of Thomas Have, for a person under act of March 9, 1678, No. 22 9/9 proof of her marriage to the soldier is required. You are informed that proof upon this point is of value in the following order:

I certified copy of the town, county, or other public record, or the sworn

copy of a church record.

2. Ansaffidavit of the officiating clergyman or magistrate. 3. The testimony of two or more eye-witnesses of the ceremony.

Affidavits of children whose ages would show the date of marriage or commencement of cobabitation.

5. A copy of family record, sworn to by custodian, certified by the magistrate to be correct, and that the original appears to be genuine. When this class of evidence is furnished it must be shown by whom and when the record was made, and the date of the Bible, or other book, in which the record is made, must be given, and it should he corroborated by other evidence of at least as high order as the (ith class.

6. The testimony of two or more witnesses who know the parties to have lived together as husband and wife from the date of their alleged marriage, the witnesses

stating the period during which they knew them thus to c habit.

Witnesses under the 2d, 3d, 4th, and 6th classes of testimony must state the circumstances or cotemporaneous events by which they are enabled to fix the date of the marriage, and the witnesses should state their ages at the time they testify.

Before any of the lower classes of evidence can be accepted, it must be shown

by competent testimony that none higher can be obtained

If the claim is for service pension under the act of February 14, 1871,

marriage must be proved at a date prior to February 17, 1815.

If the claim is for service pension under either the act of February 14, 1871, or March 9, 1878, proof will be required to show whether the claimant has again married since the death of the soldier on whose services the claim is made.

The fact and date of death of soldier must be proved

The credibility of all witnesses must be certified to by the magistrate before whom-their testimony is executed, magistrate and all witnesses must state whether they have any interest in the claim.

If the claim is for Bounty Land. widowhood at the time of making the application must be proved.
